

PUBLISHING AGREEMENT

This agreement is between CORDON PUBLICATIONS (CP) and the AUTHOR _____ for the manuscript entitled _____.

Said parties entered into this agreement on _____ (date).

The author wishes CP to publish the work and grants CP the nonexclusive right to print and publish, advertise, distribute, sell and ship the work in any way CP deems appropriate, and grants CP the right to distribute the work world wide, and collect all monies for books sold by CP. CP agrees to pay royalties on a quarterly basis to the author beginning with the last day of the first full month of publication if any are due.

Cordon Publications will (upon receipt of a signed agreement, acceptable CD files, and payment):

- 1 . Assign one of its ISBN's to the book and submit relevant information about the work to various distributors.
- 2 . Create a barcode for the back cover (necessary for bookstore related sales) and enter the book into their digital book printing system so that the book may be printed.
- 3 . Integrate the author's title and book data into Cordon's website for the work in order that it may be sold to CP's e-commerce Web sites.
- 4 . Provide information about the work to third-party sellers to enable them to sell the work, but will not be responsible for the turnaround times, submission policies, listing policies, errors, or sales policies of any third party.
- 5 . Not be held responsible for errors in the book including, but not limited to spelling errors, grammar, punctuation, style of work, page numbering, corrupted files, computer formatting errors, missing fonts. We will issue a printed proof book to the author for review in order to correct any problems that the author wishes CP to fix.
- 6 . Reserve the right to reject any work for any reason, at any time.
- 7 . Reserve the right to market the work, using methods it deems appropriate and to have the right to market and distribute the book world wide.
- 8 . Mail statements to the author in addition to any monies due.
- 9 . CP is not responsible for, but will endeavor to care for and return submitted photos and artwork; and submitted CD disks.
- 10 . Issue a Form-1099 as required by the Internal Revenue Service for any earnings exceeding \$600.00 in any one year.

The Author will:

- 1 . Will pay CP a one-time setup fee of \$700.00 and will also provide payment for any optional additional service chosen by the Author, such as editing. **ANY EXTRA TECHNICAL SERVICES NECESSARY FOR PUBLICATION SUCH AS COLOR OR COMPUTER GENERATED MANUSCRIPT SET-UP WILL BE BILLED SEPARATELY.** Any extra billing will be discussed with the author prior to publications and with author's permission.
- 2 . Maintains that he/she is the legal author of the work and owner of the copyright rights of the contents of the work and has full power to enter into

this Agreement; he/she is not engaged in plagiarism with respect to the work; and that the Author, if submitting work that is to include any content that does not originate from the Author or to which the Author does not own the copyright to, has obtained the copyright owner's written permission to use any such material and will provide CP with a copy of all written permissions for the use at the time of submission to CP, and that all such uses will be so noted in the work; and will send a copy of Copyright Form to CP after the form has been stamped and returned to the Author by the Library of Congress.

- 3 . Guarantee CP that the work is accurate, is not in violation of anyone's privacy, is not injurious, obscene, libelous, slanderous, or otherwise a violation or infringement of any federal, state, or local law, statute or code, and further agrees to hold CP, its employees, directors, shareholders, representatives, heirs and assigns, harmless or any damages resulting from any litigation resulting from publication of the work.
- 4 . Author guarantees CP that the work, IF fiction, does not include the name and/or any likeness of any actual persons, living or dead; and that all characters in the fictional work who may have been derived from actual persons have altered names, altered physical attributes, and are placed in altered locations so as to negate any similarity or likeness between the actual person, location, or event, and the fictional character, location.
- 5 . Author understands that CP shall not in any way acquire ownership of the work and that the Author is free to pursue any and all publishing venues that do not involve the use of CP's logo, barcode, copyright page, or ISBN.
- 6 . Author grants CP the right to provide services including but not limited to, the worldwide distribution of the book, advertising, sales and the printing of the work.
- 7 . Author understands that editing of the manuscript is including in this price of any work up to 400 pages. Beyond that number, editing will be priced at \$1.00 per page. If Author has had the manuscript professionally edited, there will be a \$50.00 credit on the first order of books.
CP WILL NOT PUBLISH ANY WORK THAT HAS NOT BEEN EDITED, EITHER BY A PROFESSIONAL OR BY CP.
- 8 . Author understands that CP will take the author's digital book file and do its best to fix any obvious problems resulting from the file being transferred to CP's computers before sending the author a first proof book; and that any changes that are made to the book thereafter, regardless of their origin, will be made at the Author's request and change expensed at the rate of \$15.00 per hour, excluding 100 free items requested by the author to be made by CP at no charge after the author has received the first proof book; and recognizes that correctable items can be the result of errors by the computer, by CP, or by the Author.
- 9 . Author reserves the right to discontinue the selling of the work by CP by providing written notice to CP, and acknowledges that CP is not responsible for copies of the work that have already been manufactured, sold, and/or distributed to the market.
- 10 . Author understands that the signature below ratifies all the terms and conditions of the Agreement.
- 11 . CP will give each author the "Buyer Return Program" for two years at

no cost. At the end of the 2 years, it can be purchased for additional time by contacting CP for a quotation of price at that time. The Buyer Return Program allows bookstores to return any unsold books after the time stated by their corporate offices (sometimes 6 mo.-1 year) for a full refund. **THE RETURNED BOOKS WILL BE CHARGED AND SENT TO THE AUTHOR FOR THE SAME COST THAT THE BOOKSTORE HAS PAID PLUS ANY SHIPPING CHARGES.** Authors who do not want to participate in this program may opt out of it by stating in the beginning that they are not willing to accept books returned. (Many bookstores will not stock books that are not returnable for credit and bookstores rarely order more than 12 at a time, unless the book is deemed to become a big selling item.)

General Provisions

This agreement shall be governed by the laws of the State of Indiana, USA. All monetary transactions will be in US dollars or acceptable credit cards. This written agreement contains all and is the only agreement, and supersedes any other agreement, oral, written, or otherwise construed as a prior agreement between the author and CP. This agreement cannot be appended, changed, modified, word or words added or deleted except by the mutual written agreement of the Author and CP; and further, is binding upon the heirs, executors, administrators, and assigns of the Author and CP.
